



## **PRIVACY POLICY & Personal Information Collection Statement**

This privacy policy statement sets out the policy of Seeds Skateboarding Company Limited ("Seeds Skateboarding Company Limited" or "Seedskate") concerning the way we obtain, use, disclose and/or transfer personal data through the Seedskate Hong Kong website(s). We observe and are bound by the Personal Data (Privacy) Ordinance (Cap. 486).

We understand and appreciate your concern about privacy and use of personal data. We are committed to provide you with a satisfying experience to manage your personal data under protection, and to give you the means to voice any questions or concerns you may have.

This privacy policy statement provides you with information on:

- 1. types of personal data gathered;
- 2. purposes of collecting your personal data;
- 3. disclosure and transfer of personal data
- 4. PIC statement;
- 5. retention;
- 6. direct marketing activities
- 7. security;
- 8. use of anonymous information; and
- 9. your right to access and correct your personal data.

We keep our privacy policy statement under regular review, and may amend or update this privacy policy statement. We encourage you to periodically review this privacy policy statement to keep yourself informed. If there is any inconsistency or ambiguity between the English version and the Chinese version of this privacy policy statement, the English Version shall prevail.

### 1. TYPES OF PERSONAL DATA GATHERED

Your consent will be obtained before your personal data is gathered. Subject to types of services, personal data gathered and held by Seedskate may include names, date of birth, telephone numbers, mobile numbers, email addresses, postal addresses, and/or other personal data as required for particular service(s).

With your personal data, Seedskate can provide you with various personalized and enhanced services. It is at your sole discretion to decide whether to respond to the questions and/or disclose your personal data. We hope that you will find it beneficial to provide individually identifiable information about yourself to us because it will make our website and its services more relevant to you.

We may provide you with additional privacy notice(s) from time to time where we believe that it is appropriate to do so. Those additional notices supplement and should be read together with this Privacy Policy Statement.

### 2. PURPOSES OF COLLECTING YOUR PERSONAL DATA

Your personal data will be used by Seedskate only for the purposes specified below:

- a) to administer and deliver services and products ordered by you;
- b) to sign waiver form and confirmation of your disclaimer;
- c) to contact you about your order (for example, in the event of a cancellation);
- d) to register a membership account with Seedskate;
- e) to enable you to participate in courses or competitions or to submit comments or make inquiries on our website;
- f) to investigate and deal with complaints and submit claims to our insurers where necessary;
- g) to provide service update emails regarding the service and your Seedskate account;
- h) to analyze and improve the website and services we offer for example, you may be invited to complete one of our online user satisfaction surveys;
- i) to send you marketing emails or other materials;
- j) for promotional and marketing campaigns, including photographs, images and audiovisual materials;
- k) to comply with any legal or regulatory requirements (whether in Hong Kong and/or applicable jurisdictions outside Hong Kong) from time to time; and
- I) for any other directly related purposes as required by the law.

### 3. **DISCLOSURE AND TRANSFER OF PERSONAL DATA**

There are occasions where it becomes necessary for Seedskate to disclose or transfer your personal data to third parties in Hong Kong and/or other applicable jurisdictions. Seedskate may be required to disclose your personal data in connection with the above purposes to the following third parties:

- a) Seedskate employees;
- b) affiliated companies within the Seedskate group of companies with whom we share personal data for information management purposes;
- c) banks and payment providers to authorize and complete online payment transactions;
- d) service providers, agents, and contractors that support Seedskate's business, for example, IT service providers, marketing service providers, and data analytics providers;
- e) insurance companies; and/or
- f) law enforcement agencies, regulatory authorities, and/or emergency services;

### 4. PICS Statement

The information collected from you will be used for the purpose of processing your purchase orders and managing your account with us:

a) Please provide your telephone number in case we need to contact you about your comments on our services. You do not have to tell us your phone number but it will help us to contact you quickly if we have a question about your comments.

b) Where cookies are used on websites to collect information about visitors: "Most web browsers are initially set up to accept cookies. You can choose to 'not accept' cookies by changing the settings but if you do so you may find that certain features on the website, including online banking, do not work properly."

#### **5. RETENTION**

We will retain personal data for no longer than is necessarily required for the aforesaid purposes, subject to any legal and regulatory requirements.

### **6. DIRECT MARKETING ACTIVITIES**

We would like to use the personal data you provide to us, including your name, email address, phone number, and postal address, for direct marketing purposes. This may include keeping you posted about Seedskate services, inviting you to events, sending you offers and promotions, asking you to participate in events or competitions, and providing other marketing materials about services and related activities that may interest you. We may only do so if you have given your consent, and we will ask for your permission before using your personal data in such a manner.

Your name, mobile phone number and home address collected by us will be used for providing you with information about recreational activities and special offers on courses, to be provided or sponsored by us. We cannot use your personal data unless we have received your consent or indication of no objection.

#### 7. SECURITY

We operate secure data networks designed to protect your privacy and security against loss, unauthorized access, use, modification or disclosure of personal data. Only authorized staff member(s) will be permitted to access such personal data.

#### 8. USE OF ANONYMOUS INFORMATION

Seeds Skateboarding Company Limited automatically gathers anonymous information to monitor the use of our website, like the numbers and frequency of visitors. For example, the following information may be logged for statistical purposes: your internet protocol address, the date and time of your visit to our site, the pages that you have accessed and the documents downloaded, and the type of browser you were using.

Tracking technologies such as cookies may be used on our website to recognize your browser each time you visit our site and track the pages you visit. Cookies are pieces of information that a website transfers to a computer's hard disk for record-keeping purposes. Most web browsers are set to accept tracking technologies such as cookies. These tracking technologies do not personally identify you. You have a choice not to accept the cookies. We only use such data in the aggregate. We endeavor to ensure that all information we collect, use, or disclose about you is accurate, complete, and up-to-date.

Seedskate is entitled to charge reasonable fees for processing the said request.

# 私隱政策及個人資料收集聲明

## 1. 收集的個人資料類型

## 2. 收集您的個人數據的目的

Seedskate 將僅將您的個人資料用於以下指定目的:

- a) 管理和交付您訂購的服務和產品;
- b) 簽署並確認您的免責聲明:
- c) 就您的訂單與您聯繫(例如, 在取消訂單的情況下);
- d) 在 Seedskate 註冊會員賬戶;
- e) 使您能夠參加課程或比賽或在我們的網站上提交評論或進行查詢;
- f) 調查和處理投訴, 並在必要時向我們的保險公司提交索賠;
- g) 透過電子郵件以更新您有關提供的服務和您的 Seedskate 帳戶;

## 3. 個人資料的披露和轉讓

在某些情況下,Seedskate 有必要向香港及/或其他適用司法管轄區的第三方披露或轉移 您的個人資料。 Seedskate 可能需要向以下第三方披露與上述目的相關的您的個人資料:

- b) Seedskate 公司集團內的關聯公司,基於信息管理目的與這些公司共享個人資料;

## 4. 收集個人資料聲明

收集的資訊將用於處理您的訂單和管理您在我們這裡的帳戶:

### 7. 保安
